# Heijmans Policy Circular Packaging Materials

## Packaging

The Contractor shall conform to the Client's packaging materials policy. The object of this policy is to make sure that suppliers and sub-contractors, i.e. the Contractor too, can return all packaging materials for reuse or recycling purposes. This is in conformity with the Circular Packaging Materials appendix.

From 1 January 2020, the contractor will make every effort to offer all packaging materials in such a way that 100% of the material can be processed or recycled in a circular fashion. From January 1, 2021, this best efforts obligation will be a result obligation.

The starting point is that packaging materials are always made of mono materials, i.e. no composite packaging materials such as cardboard boxes with plastic windows etc.

The column "Material" contains only those materials that are accepted by the Client as packaging material for the Contractor to use when carrying out the work, rendering services and supplying goods/products and anything related to those activities.

The table sets out three forms of use of packaging materials. Form 1 is preferred over Form 2 and Form 2 is preferred over Form 3.
